# VILLAGE OF ATHENS BOARD MEETING JULY 28, 2021

Public Hearing on NY Stretch—Mike DeWein attended from North Branch Services

It was discussed that the Historic District would be exempt from the NYS Stretch Code. Opting out of clean air ventilation systems and the heat or energy recovery ventilator.

Washington Street, Athens N.Y. as parkland; and further

# Trustee Lipsman-

The CAC/Tree Committee submitted an application to be a Tree City USA. Two signs will be posted by the DPW. He also said that the CAC submitted an annual report. The Clean Energy Committee NY Stretch Code will give us 1200 points and there will be CEO training in September. He is also working with 2 solar companies that residents can opt in on and he is waiting on the CHGE to provide the go ahead for the electric charging station.

#### Mayor Serrago-

She stated that there will be some COVID restrictions at APAC. Mask will be required, there will be announcements during the concert. Marya will donate masks and she will speak with Carol Bernard.

She said that the CDBG was sent Monday with the recorded hours.
