# Village of Athens Board Meeting

July 26, 2023

Present: Mayor Serrago, Trustee Lipsman, Trustee Phoenix, Trustee Lasher, and Trustee Scott

Meeting began with the pledge to the flag at 6:30pm

#### **PUBLIC:**

Whitney Parshall

Ms. Parshall was present to speak about 7 North Washington Street. She said this property has been vacant for at least 30 years. She said that it was bought to relocate her mother-in-law. She said she hired a plumber and was told by Code Enforcement she would need an engineer. The estimate for this all was about \$17,000.00. She said that the DPW has come out to the property a few times and she was told the lines from the house to the main would be her responsibility. She said that it was never discussed that there would be a connection fee. Most recently she said they had told her it would be \$4,000.00 to connect to the water system. She said she has nothing in writing. She said these additional fees are devastating. She said the conversation she had with the DPW was totally different than what her plumber had. She said she would like clarity in writing and who is supposed to do what. She said she has a lot of money going out to save this property.

Mayor Serrago said that this is not a new hookup for water and sewer. She said anything from sidewalk to the main is the property owner's responsibility.

DPW Supervisor Sprague said that the homeowner will have to pay the fees for work done and he thinks it may be around \$3000.00. He said he has estimated a little higher as he is not sure yet what the cost will be. He also said this line has not been used in years and he does not know what they are getting into.

Mayor Serrago said that any work done by the DPW would have a fee as the line will need extensive repairs, but not an application fee. She said we cannot give a written estimate at this time as we do not know what exactly needs to be done.

Ms. Parshall said that there were 2 different conversations. She said the plumber and the DPW need to be on the same page.

DPW Supervisor Sprague said that he can meet with the plumber.

Mayor Serrago aske the Supervisor about how many hours of work and manpower would be needed for this job. She said that we can give a rough estimate within a week or two, but once the job is started it opens a can of worms.

## Kathy Jackson

Ms. Jackson was present to explain geocaches. She said the library would like to put some around the Village. It is like a Scavenger hunt.

Mayor Serrago said she will put this in the newsletter.

The board said this could be approved to do in the Village.
