Village of Athens Board Meeting September 13, 2023

Present: Mayor Serrago, Trustee Phoenix, Trustee Lasher, Trustee Lipsman

Absent: Trustee Scott

Department Heads:

Water/Sewer- Joe Myers

Joe said that an assessment had been done of the Legion Hall. He said that Chris contacted Rural Water. There were no leaks. He believes this is a storm water issue as there is a storm drain along the side of the building.

Chris said that maybe they could jet out the storm drain for them, but that was about all that could be done.

Joe said that the flows were down. He said this is due to improvements to the system and the rain that we had. He said that the tanks were cleaned. He said that water samples are clear. Joe showed an example of a water main and explained why there is still some brown water. He said it is a form of iron and sediment. He also said that it is because of the cast iron pipes that are unlined. He said now that we will be on a flushing schedule it will help inhibit the growth. Joe said that the sewer looks good.

Trustee Lipsman said there is a grant opportunity available until November for energy efficiency.

Joe said that he would look at it.

Mayor Serrago asked that dredging be done in the Spring. She would like the numbers for that. Either bring in a contractor or look into getting equipment.

Trustee Phoenix said that renting may be less expensive.

DPW-Chris Sprague

Chris said that there were 2 water main breaks that were not major. He said the department assisted Coxsackie with a water main break they had. He said they started the storm drain project, but it took a little longer because of 5 gas lines they had to contend with. Last week's storm left some damage. He said that they had trimmed the alleys up. He said there were some violations that Code Enforcement is taking care of. Chris said he would like to look into a mower as the one they had blew up. He said he would like to get 2 so he could get some part timers in here to work on mowing.

Mayor Serrago said that could be discussed at the next meeting.

Chris said there is a Campground on Schoharie Turnpike that is adding more sites and they would like to get water from the Village.

Joe Myers said he would have to contact the Health Department as he estimates 120,000 gallons a day.

Chris asked if we were charging Coxsackie for the help they gave, and the board decided it would be shared services. Chris said he interviewed a candidate for the position that is open on the DPW, he said

the candidate is stable and was at his last job for 4 years. He said that he and Trustee Scott will interview him again.

Trustee Lipsman asked when fall cleanup day would be.

Chris asked if he could get a quote for the cleanup of the brush pile. He also said there has been afterhours activity there. He said a brush company has been dumping.

There was a discussion about the brush pile and hours it should be open to cut down on this activity.

Chief Butterworth said that people using the brush pile are not moving for fire personnel when they are responding to emergencies.

Mayor Serrago said to order the security cameras for the DPW. She also said to close the gate on the road between the senior citizens building.

It was decided that the brush pile would be open Monday -Saturday 7am-3:30pm and Chris will open and close the gate.

Fire Department-Wayne Butterworth

Wayne said that Pizza will start the last week in September. He said that the Fire Prevention is in a few weeks and the department will be doing the Pumpkin Parade. He said there is a situation with the Rescue Truck. It needs repairs and will cost \$135.00 an hour and needs at least 40hrs of repairs.

Trustee Serrago said any legitimate bill we will figure out how to pay.

Police Department-Ed Tercasio

Trustee Lasher said that vouchers need Roger's signature and Code has some too.

Trustee Lasher asked if the Opera House store had been checked for anything. Tercasio said that he would do a commercial fire inspection.

Police Department-Ed Tercasio

Ed spoke about a grant they have received for a vehicle. The village attorney told them how to go about the bid process. Ed said they received an email about an extension of money for vests. He said the village would need to put the money out first and then they would be reimbursed. He said they have until Oct 20th to order. He said they may be about \$1100.00 each so they may need to eat \$400.00 of this. He said that car 305 went to Hendricks and it will need a new transmission and axle. The cost was \$5000.00. He said they aren't going to fix it they are going to take it to the DPW and take everything out of it and put it up for auction as is. Ed said that there are body cameras available through the Sheriff Department at \$495.00 apiece. He said the department wants 4 cameras and server would be \$2000.00 to \$2500.00. He said any FOIL requests would go through the Sheriff Department and they would store everything. He said they would also need to pay for a dedicated line from Athens to the Sheriff Department which would cost about \$150.00 a month.

Mayor Serrago asked if this could wait until the next budget.

Trustee Lipsman asked if this was a requirement.

A MOTION was made to allow the Police Department to order vests at a cost of \$1100.00 each.

Carol Pfister also mentioned that applications are due for the Community Foundations Grants by October 31st.

Trustee Lipsman said he will not be here at the next meeting.
