MINUTES – VILLAGE OF ATHENS BOARD MEETING AUGUST 28, 2024

PLEDGE TO THE FLAG

Meeting held in the Athens Village Community Center at 6:00PM

PRESENT: Mayor Amy Serrago, Trustee Gail Lasher, Trustee Josh Lipsman and Trustee Joey Dillberg.

Village Attorney Tal Rappleyea was also present.

Clerk-Treasurer MJ Wynne was also present for the purpose of taking minutes.

PUBLIC:

1. Jason Preisner, representing Lamont Engineering, attended the meeting to provide the village with a status report on all of the village's ongoing projects:

Water project

Wastewater project

Community Center gym rehabilitation

Community Center rehabilitation Study

Hollister Lake weed harvesting project

Discussion ensued regarding each project.

2. Patrick Gillespie, resident of Second Street, attended the meeting for the purpose of discussing the water/sewer bill he receives from the village quarterly. He doesn't understand what the abbreviations mean. It doesn't include anything other than gallons used.

Recently Mr. Gillespie came to the Clerk's office and was given a water budget and also received answers to the questions he had regarding his water bill.

Mr. Gillespie stated he later spoke to DPW Super Sprague on the street where he explained everything about water billing and budgeting to him and now, he is 'all good'.

Jason Preisner, Lamont Engineering noted that billing software for water and sewer is limited as to what it prints out on the bill and the office doesn't have a lot of control over that. The application software prints the actual bill. The office/metering software provides the data.

3. Kathy Jackson, representing the DR Evarts library, attended the meeting due to the fact that she has submitted an application for water hookup as part of the renovations at the Library. They require a different hookup due to the new sprinkler systems.

DPW Super Sprague noted that the library currently has a ¾" line and they need a 4" line for the proposed sprinkler system.

Ms. Jackson also noted that they are required to complete a flow test ASAP.

DPW Super Sprague informed the VB that the flow test disrupts the water system which has had a lot of stress on it lately and he would like to do the flow test in conjunction with the hydrant flushing scheduled for the first week of October tentatively.

Jason Preisner (Lamont Engineering) stated that they may be able to do the flow test. He also noted that it may not be necessary as there was one completed a couple of years ago and that may suffice. He will check.

Discussion of costs related to the flow test and the work for the water line ensued.

DR Evarts will pay for the application fee and the village DPW will provide labor.

4. Richard Greene, resident of N. Montgomery Street, attended the meeting to revisit his curb issue discussed at a VB meeting previously after the road had been paved in front of his house last year.

Mr. Greene asked if there were any progress with replacing the curb or should he just put in landscape stone?

DPW Super Sprague discussed the problem with the curb and stated that he would take care of the problem and to give him a little time.

6. Ralph Vendresco, village resident, attended the meeting to follow-up on his previous visits regarding delinquent properties. It doesn't look like anything has happened. Has there been any progress?

Mayor Serrago asked the Village attorney if she could speak on behalf of an ongoing case?

Village Attorney stated 'no'.

Mayor Serrago stated that she is pleased with how things are progressing with one case in particular and reiterated that these matters take time.

The Village Attorney stated that the biggest problem is being worked on.

Mr. Vendresco asked if he should fill out a complaint form?

Reply is 'yes' that would be a big help.

Mr. Vendresco noted that the Code Enforcement Officers drive around in police cars throughout the village don't they see what's going on?
